Forklift of up to 2000 Kgs lifting capacity      **EUR 150.00** per hour – Minimum charge per order, 1 hour.

### Hire of Manpower

This service is available, if an exhibitor likes to hire additional labour for assistance on the stand. The scope of work includes only working on the stand to assist the exhibitor with stand dressing and set up of the booth only and cannot be utilized for loading or offloading of boxes / freight at the marshalling yard.

Un-Skilled Labour      **EUR 60.00** per man, per hour - Minimum charge of 4 hours.

Packer / Foreman      **EUR 75.00** per man, per hour – Minimum charge of 4 hours.

Use of Resa import tax registration number for permanent import good is subject to a service fee of **EUR 110.00** per consignment per entry.

### Empties and Full Goods Storage during the exhibition

Collection, storage and re-delivery of empty cases charged at **EUR 55.00** per CBM per shipment per exhibitor with a **Minimum 3 CBM** charge per shipment per exhibitor.

Collection, storage and re-delivery of full goods cases charged at **EUR 80.00** per CBM per shipment per exhibitor with a **Minimum 2 CBM** charge per shipment per exhibitor.

Heavy-lift surcharge will apply for an individual item over 2000 kilograms and also for units in excess of **200 x 200 x 150cms**. **Surcharge will be +50% of tariff handling rates.**

Customs Examinations, if applicable will be charged at **EUR 215.00** per consignment, per examination. Quality Inspection (SOIVRE) if applicable @ **EUR 115.00** per consignment per examination

Spanish Customs Duties and taxes, if applicable are charged as per outlay as assessed by Spanish Customs plus 15% advancement fee, Minimum chargeable of **EUR 55.00** per consignment per waybill.

Conversion fees from temporary to permanent charged per prime customs bill of entry **EUR 210.00** per entry per consignment.

Advancement fee of 15% applicable to all additional charges outlaid by us on your behalf. This applies to Customs Duty, Taxes, port storage, terminal handling, detention, Customs penalties, fines etc.

Late arrival surcharge at **50%** of the tariff handling charges (if applicable).

Overtime, late evening working (after 20 hrs), weekend working or working on public holidays will be subject to a **50%** surcharge on the tariff handling rates and will be charged additionally

Removal of handling of sold exhibits and cargo to the warehouse for completion of permanent import conversation process will be charged additionally and quoted on a case to case basis.

\* Express deliveries for urgent deliveries (delivery on the same day of arrival) will be subject to an Extra charge of **EUR 180.00** per consignment, per move.

Consolidated goods which require deliveries to different stand / any additional delivery required on site during the exhibition is subject to Additional Delivery/Split Delivery fee of **EUR 180.00** per delivery.

Handover of import/export shipping documents are subject to a handover fee of **EUR 95.00** per consignment, per document.

Courier Export processing fees charged at **EUR 115.00** per document, per exhibitor, per shipment.

Extra charges for express deliveries (delivery on same day of arrival) @ **EUR 185.00** per way per delivery

Shipments delayed in export either by air, sea or road by more than 15 days from the close of the show, will be subject to a storage fee, additional handling and transportation fees covering the movement into the warehouse for interim storage. This will be quoted on a case to case basis where applicable.

## 7) Miscellaneous Remarks

All other rates quoted herein exclude: -

- Airline/Airport/Seaport storage or demurrage charges if applicable will be additional on early arrival shipments (irrespective of the cargo arrival deadlines mentioned in the shipping guidelines). The free time permitted for shipments is 5 days from the port and shipping line for the containers to be unloaded and delivered back to port, effective from date of arrival.
- VAT applicable to Spanish companies or where applicable.
- Any third party charges incurred, beyond our control.
- Storage and handling of empty cases are subject to availability of free storage space on-site. Additional charges may apply for off-site storage or charges levied by the venue towards the space required on-site.
- Split delivery of freight into different stands/halls locations, where additional handling is required.
- Unforeseen charges, such as loading/unloading, packing/unpacking at sea/airport for Customs inspection.
- Comprehensive Insurance (available upon request)
- Provision of hire of equipment and manpower – fork lift, crane, pallet truck, packing materials, labour etc.
