- Manpower or equipment, which may be required to assist exhibitors, will be additional

**IMPORTANT NOTES:**

All freight destined for the show must be declared at least 5 working days in advance for planning purposes. Declarations must include cargo details such as, AWB or B/L copy, weight, volume, exhibitor name & stand number. This will only enable us to serve you better, also we expect that your representative (not the driver) will be on-site at the time of the delivery to sign the necessary work orders.

For any exhibit or piece which exceeds more than 2 tons a piece, or with dimensions that exceed 2.0m x 2.0m x 1.5m (or any piece more than 5 CBM in volume) where special handling & lifting is required, the exhibitor/agent is required to contact GT Exhibitions, to offer a special handling & lifting quotation.

We take necessary precautions by covering all cargo and empty cases. However the show site yard is not a covered site, therefore all freight and empties moving in and out of the halls or stored on site during the show are exposed to climatic conditions.

Our tariff is computed on the basis of volume and weight and has no correlation with the value of exhibits. The cost of insurance cover is not included in our scope of work / tariff and the same must be arranged by the Exhibitor and / or Exhibitor company with an express and unconditional waiver of subrogation towards GT Exhibitions, our partners & sub-contractors.

It is the responsibility of each individual freight agent and exhibitor to ensure the collection of the packed goods from the stand at the end of the show within the stipulated tenancy. We are not responsible for any missing exhibits from the booth.

**LABOUR**

GT Exhibitions is the only company authorized to work on site and provide labour for the handling/movement of freight within the premises of the exhibition centre.



## 5) Additional Charges

ALL CHARGES IN US\$

Shipping/Airline, air/sea port and terminal handling fees, exchange BL or DO fees, customs bonded warehouse storage and handling fees, customs duty, Taxes, Egyptian VAT, any Ministry/government department import permits or approval fees and all other third party charges will be charged per official receipt plus 15 %.

Egyptian service fees charged additionally estimated at **14%** of the total invoiced amount. Charged both on inbound and outbound.

For shipments that require special permits from governmental departments such as Ministry of Health, Municipality or any other government authorities, all costs will be billed as per receipt plus an intervention fee of **USD 115.00** per clearance.

Assistance with Unpacking and Re-packing of goods, if required will be charged additionally and can be quoted upon request.

For any box or crate, which exceeds more than 2 tons per piece or with dimensions that exceed 2m x 2m x 1.5m (LxWxH), where special handling and lifting is required, we request exhibitors/clients to contact us, providing a detailed description of the goods at least 20 days prior to the start of the exhibition. This is very importation and is required to ensure a smooth handling of your goods at the show site. Failure to do so in advance will invite penalties and surcharges to mobilize such special equipment at a short notice, which if applicable will be on the respective exhibitors/client's account.

Egyptian Customs Duties on the sold/given-away goods, assessed by Customs.

**Advancement fee of 15%** applicable to all additional charges outlaid by us on your behalf. This applies to Customs Duty, Taxes, legalization fees, customs examinations, waiting time or detentions, overtime or holiday surcharge, port storage, terminal handling, detention, Customs penalties, fines, arrival fees and any other third party fees, etc.

Removal and handling of sold exhibits and cargo from stand to transferred customs bonded warehouse for completion of permanent import conversation will be charged at **USD 65.00** per CBM with a **Minimum 3 CBM** charge per shipment per exhibitor.

Late arrival surcharge at **25 %** of the basic handling charges (if applicable).

Weekend and Holiday Surcharge at **50 %** of the basic handling charges (if applicable).

Temporary import Bond is valid for 30 days from the date of entry, before which time all the goods must be either re-exported or converted into permanent import. Failing which additional bond fees of **3 % of the CIF Value (Minimum USD 180.00)** per consignment per waybill will apply for each additional 20 days.

Storage of Empty Containers on Site During the Show, if required can be quoted upon request.

Shipments delayed in export either by air or sea by more than 4 days from the close of the show, will be subject to a storage, handling and transportation fees which will be quoted and charged additionally on a case to case basis for movement into the warehouse for interim storage.

**Rental of Forklift**

This service is available for the set-up of exhibits if required. The scope of work includes only working on the stand for the assembly /dismantling of exhibits and cannot be utilized for loading or offloading of exhibits / freight at the marshalling yard.

**Hire of Manpower**

This service is available, if an exhibitor likes to hire additional labour for assistance on the stand. The scope of work includes only working on the stand to assist the exhibitor with stand dressing and set up of the booth only and cannot be utilized for loading or offloading of boxes / freight at the marshalling yard.

Un-Skilled Labour

**USD 30.00** per hour - Minimum charge 3 hours.

The above charges are subject to Overtime and Holiday Surcharge @ 50% for work carried out after normal working hours. On Friday, Saturday, public/bank holidays, late working after 6 pm in the evening or before 8 am in the morning.

The above is also subject to Egyptian service fees charged additionally estimated at 14% of the total invoiced amount. Charged both on inbound and outbound.

**7) Miscellaneous Remarks**

All other rates quoted herein exclude: -

- Cargo and Transport Insurance.
- Airline/Airport/Seaport/Venue customs bonded warehouse storage or demurrage charges if applicable will be additional on early arrival shipments (irrespective of the cargo arrival deadlines mentioned in the shipping guidelines).  
The free time permitted is 5 days from the port and shipping line for the containers to be unloaded and delivered back to port, effective from date of arrival.
- Any third-party charges incurred, beyond our control.
- Storage and handling of empty cases are subject to availability of free storage space on-site. Additional charges may apply for off-site storage or charges levied by the venue towards the space required on-site.
- Application and securing of any Import permits required on commodities controlled by the Import Control Regulation authority.
- Split delivery of freight into different stands/halls locations, where additional handling is required.
- Unforeseen charges, such as loading/unloading, packing/unpacking at sea/airport for Customs inspection.
- Provision of hire of equipment and manpower – forklift, crane, pallet truck, packing materials, labour etc.

For additional services not listed above, individual quotations will be provided based on your requirement. Rates quoted basis current rates and tariffs, subject to changes with / without prior notice.
