### 3) Courier Shipments

#### IT IS NOT RECOMMENDED TO SEND ANY COURIER SHIPMENTS TO CASABLANCA FOR THIS EXHIBITION

Courier companies are/may not be able to arrange Customs Clearance formalities in Algeria

If any courier shipments arrive Algeria Airport the courier company will contact our agent to arrange the customs clearance however this is a very lengthy process and it cannot be guaranteed that clearance and delivery will be achieved.

Clearance and handling charges will be charged on a case by case basis and payment must be received in advance of our assistance

Import Duties & Taxes must be paid on any shipment sent by courier

### 4) Tariff – Rental of Forklifts and Manpower

#### **Rental of Forklift**

This service is available for the set-up of exhibits if required. The scope of work includes only working on the stand for the assembly /dismantling of exhibits and cannot be utilized for loading or offloading of exhibits / freight at the marshalling yard.

Forklift of up to 2000 Kgs lifting capacity                      **€75.00** per hour – Minimum charge per order, 2 hours.  
Minimum charge per day    **8 hours**

#### **Hire of Manpower**

This service is available, if an exhibitor likes to hire additional labour for assistance on the stand. The scope of work includes only working on the stand to assist the exhibitor with stand dressing and set up of the booth only and cannot be utilized for loading or offloading of boxes / freight at the marshalling yard.

Un-Skilled Labour    **€35.00** per man, per hour - Minimum charge 4 hours.

Above charges are based per shipment, per exhibitor, per waybill

The above rates Include: -

- Receiving of cargo from the marshalling yard at the show site
- Unloading and/or de-stuffing of trucks and delivery to exhibition stand (first time spotting)
- Removal and un-secure storage of empty cases during the exhibition on site only
- Re-delivery of empty cases to the stand at the end of the exhibition
- Collection of packed goods from the stand
- Loading and/or stuffing of trucks at the marshalling yard at the show site

The above handling charges exclude –

- Cargo and Transport Insurance
- Unpacking or Re-Packing charges
- Overtime or Holiday surcharge
- Re-positioning of exhibits after delivery to stand
- Any special handling for overweight / sized pieces
- Manpower or equipment, which may be required to assist exhibitors, will be additional.

Chargeable weight / volume ratio for Sea freight @ 1:1 or as declared on the waybill whichever is higher.

#### IMPORTANT NOTES:

All freight destined for the show must be declared at least 48 hours in advance for planning purposes.

Declarations must include cargo details such as, AWB or B/L copy, weight, volume, exhibitor name & stand number. This will only enable us to serve you better, also we expect that your representative (not the driver) will be on-site at the time of the delivery to sign the necessary work orders.

For any exhibit or piece which exceeds more than 2 tons a piece, or with dimensions that exceed 2.3m x 2.3m x 2.3m (or any piece more than 5 CBM) where special handling & lifting is required, exhibitor is required to contact GT Exhibitions, to offer a special handling & lifting quotation.

It is the responsibility of each individual freight agent and exhibitor to ensure the collection of the packed goods from the stand at the end of the show within the stipulated tenancy. We are not responsible for any missing exhibits from the booth.

## 6) Additional Charges

- **Sales not allowed in Algeria for Exhibition Goods.**  
Only give away & promotional items can be cleared on permanent entry basis in Algeria. All other products can be cleared only under temporary import into Algeria. Any and all goods if sold during the exhibition must be re-exported out of Algeria soon after the exhibition, before it is returned again back into the country for permanent importation/use.
- Above rates are based on ground floor exhibits only. A surcharge of **€15.00** per CBM will apply for above ground (Mezzanine floor) exhibits.
- For shipments that require special permits from governmental departments such as Ministry of Health or Municipality, all costs will be billed as per receipt plus **€115.00** per clearance.
- Heavy-lift surcharge will apply for an individual item which exceeds more than 2000 kilograms per piece or where any one dimension exceeds **230 x 230 x 230cms**. **Surcharge will be +35% of tariff handling rates.**
- Failure to declare true and accurate values on the shipping invoice including mis-declaration of the Country of origin against the physical cargo, the Customs re-evaluation penalty will be applicable
- Storage of stand fitting material / tool boxes to be returned directly after the close of the show, or accessible storage, can be quoted on request.
- Shipment / Equipment lashing on request
- Algerian Customs Duties, which are based on the **CIF value** of the goods, assessed by Customs.
- **Advancement fee of 25%** applicable to all additional charges outlaid by us on your behalf. This applies to Customs Duty, Taxes, port storage, terminal handling, detention, Customs penalties, fines etc. (other than those mentioned above).
- ATA Carnet intervention at **€250.00** per exhibitor /document per shipment (if applicable).
- Late arrival surcharge at **50%** of the basic handling charges (if applicable).
- Shipments delayed in export either by air, sea or road will be subject to additional handling, transportation and storage fees.

## 7) Miscellaneous Remarks

All other rates quoted herein exclude: -

- Airline/Airport/Seaport storage or demurrage charges if applicable will be additional on early arrival shipments (irrespective of the cargo arrival deadlines mentioned in the shipping guidelines). The free time permitted for shipments is 5 days from the port and shipping line for the containers to be unloaded and delivered back to port, effective from date of arrival.
- Any third party charges incurred, beyond our control.
- Dangerous Goods DGR, Reefer or high valued cargo will be subject to a 100 % surcharge.
- Storage and handling of empty cases are subject to availability of free storage space on-site. Additional charges may apply for off-site storage or charges levied by the venue towards the space required on-site.
- Split delivery of freight into different stands/halls locations, where additional handling is required.
- Unforeseen charges, such as loading/unloading, packing/unpacking at sea/airport for Customs inspection.
- Provision of hire of equipment and manpower – fork lift, crane, pallet truck, packing materials, labour etc.
- For additional services not listed above, individual quotations will be provided based on your requirement.
