#### 4) Courier Shipments

Courier companies are not able to arrange Customs Clearance formalities in Morocco

If any courier shipments arrive Casablanca Airport they will contact our agent to arrange the customs clearance however this is a very lengthy process and it cannot be guaranteed that clearance and delivery will be achieved.

Clearance and handling charges will be charged on a case by case basis and payment must be received in advance of our assistance

Import Duties & Taxes must be paid on any shipment sent by courier

#### 5) Tariff – Rental of Forklifts and Manpower

##### **Rental of Forklift**

This service is available for the set-up of exhibits if required. The scope of work includes only working on the stand for the assembly /dismantling of exhibits and cannot be utilized for loading or offloading of exhibits / freight at the marshalling yard.

Forklift of up to 2000 Kgs lifting capacity                      **EURO 125.00** per hour – Minimum charge per order, 2 hours.  
Minimum charge per day    **8 hours**

##### **Hire of Manpower**

This service is available, if an exhibitor likes to hire additional labour for assistance on the stand. The scope of work includes only working on the stand to assist the exhibitor with stand dressing and set up of the booth only and cannot be utilized for loading or offloading of boxes / freight at the marshalling yard.

Un-Skilled Labour    **EURO 25.00** per hour - Minimum charge 4 hours.

## 6) Additional Charges

- For shipments that require special permits from governmental departments such as Ministry of Health or Municipality, all costs will be billed as per receipt plus **€115.00** per clearance.
- Heavy-lift surcharge will apply for an individual item which exceeds more than 2000 kilograms per piece or where any one dimension exceeds **230 x 230 x 230cms**. **Surcharge will be +35% of tariff handling rates.**
- Failure to declare true and accurate values on the shipping invoice including mis-declaration of the Country of origin against the physical cargo, the Customs re-evaluation penalty will be applicable
- Storage of stand fitting material / tool boxes to be returned directly after the close of the show, or accessible storage, can be quoted on request.
- Re-issuing export bill of lading / AWB or HAWB **€400.00** per document, which includes amendments / incorrect return shipping instructions.
- Shipment / Equipment lashing on request
- Moroccan Customs Duties, which are based on the **CIF value** of the goods, assessed by Customs.
- **Advancement fee of 15%** applicable to all additional charges outlaid by us on your behalf. This applies to Customs Duty, Taxes, port storage, terminal handling, detention, Customs penalties, fines etc. (other than those mentioned above).
- ATA Carnet intervention at **€200.00** per exhibitor /document per shipment (if applicable).
- Late arrival surcharge at **50%** of the basic handling charges (if applicable).
- Shipments delayed in export either by air, sea or road will be subject to additional handling, transportation and storage fees.
- Overtime Surcharges (if applicable):

Weekdays after 1800 hrs:	+50%
Saturdays 0800 – 1800 hrs:	+50%
After 1800 hrs:	+100%
Sunday / National Holidays:	+100%

## 7) Miscellaneous Remarks

All other rates quoted herein exclude: -

- Airline/Airport/Seaport storage or demurrage charges if applicable will be additional on early arrival shipments (irrespective of the cargo arrival deadlines mentioned in the shipping guidelines). The free time permitted for shipments is 5 days from the port and shipping line for the containers to be unloaded and delivered back to port, effective from date of arrival.
- Any third party charges incurred, beyond our control.
- Storage and handling of empty cases are subject to availability of free storage space on-site. Additional charges may apply for off-site storage or charges levied by the venue towards the space required on-site.
- Split delivery of freight into different stands/halls locations, where additional handling is required.
- Unforeseen charges, such as loading/unloading, packing/unpacking at sea/airport for Customs inspection.
- Provision of hire of equipment and manpower – fork lift, crane, pallet truck, packing materials, labour etc.
- For additional services not listed above, individual quotations will be provided based on your requirement.
